FIGURE 1. POPULATION DISTRIBUTION: FRESNO COUNTY

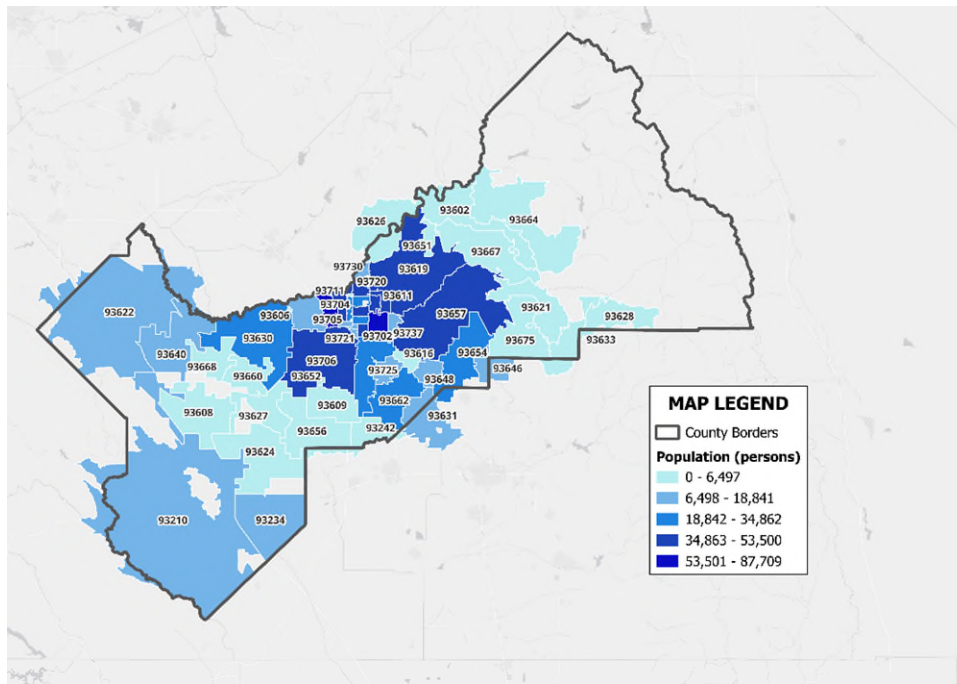
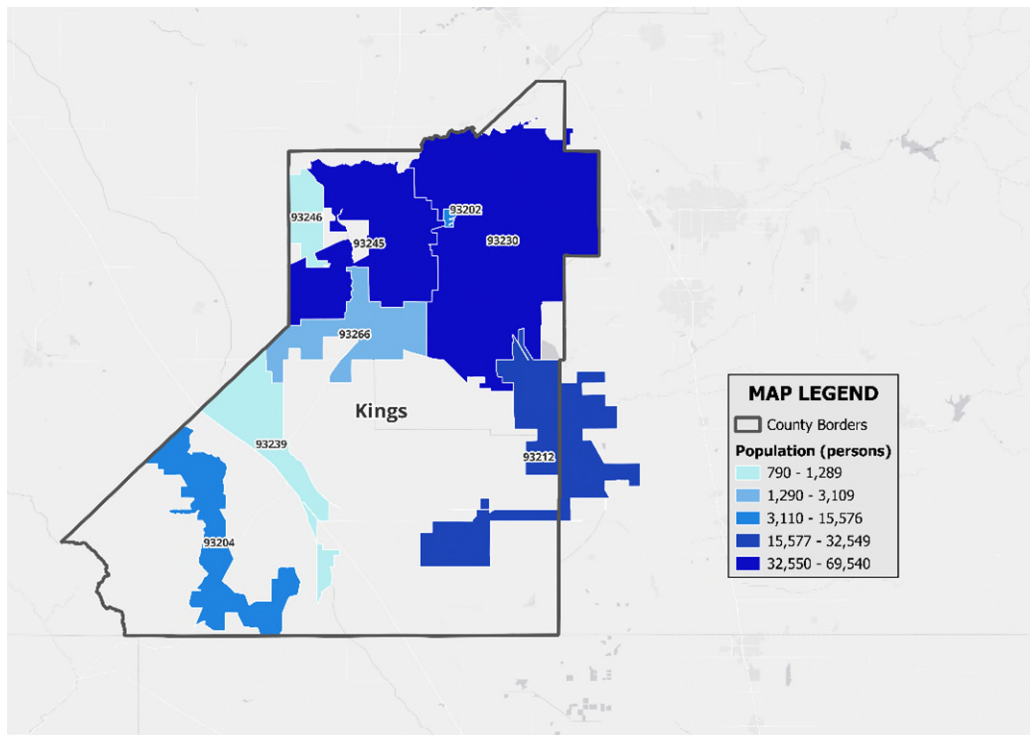


FIGURE 2. POPULATION DISTRIBUTION: KINGS COUNTY

FIGURE 3. POPULATION DISTRIBUTION: MADERA COUNTY

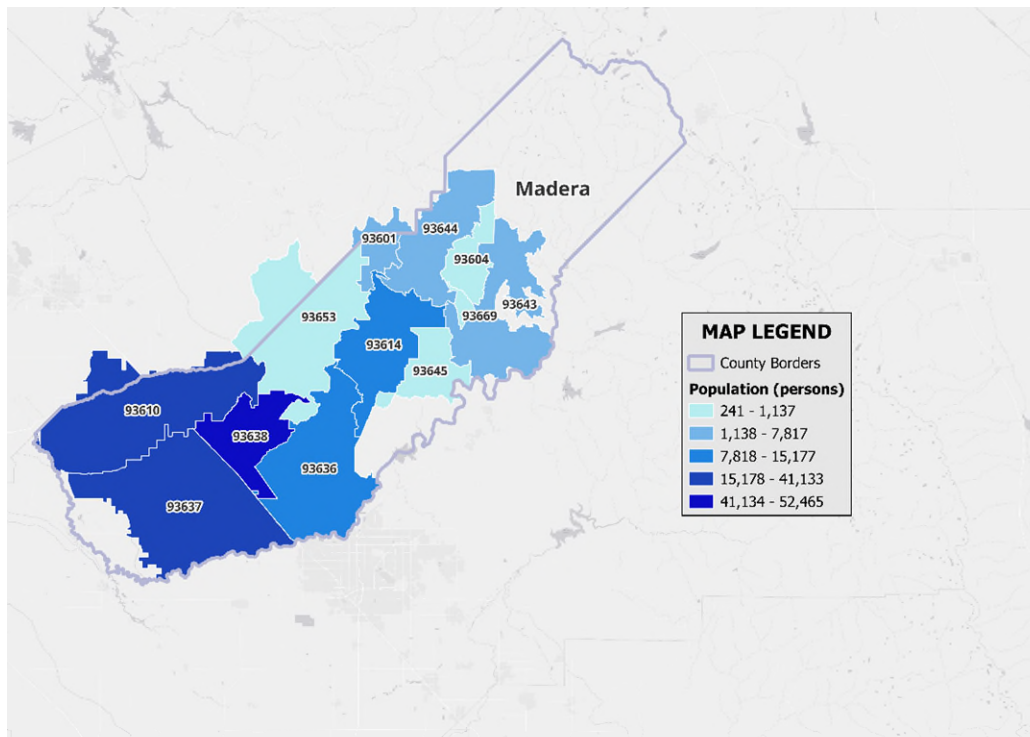
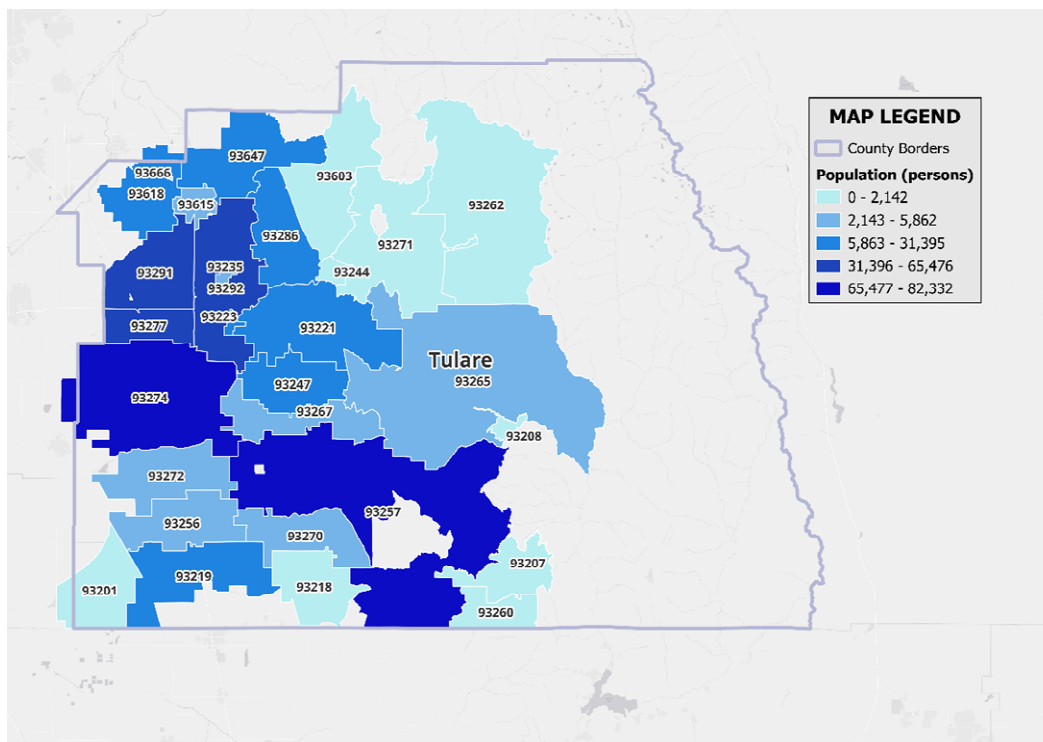


FIGURE 4. POPULATION DISTRIBUTION: TULARE COUNTY

FIGURE 5. PERCENT POPULATION BY AGE: COUNTY AND STATE

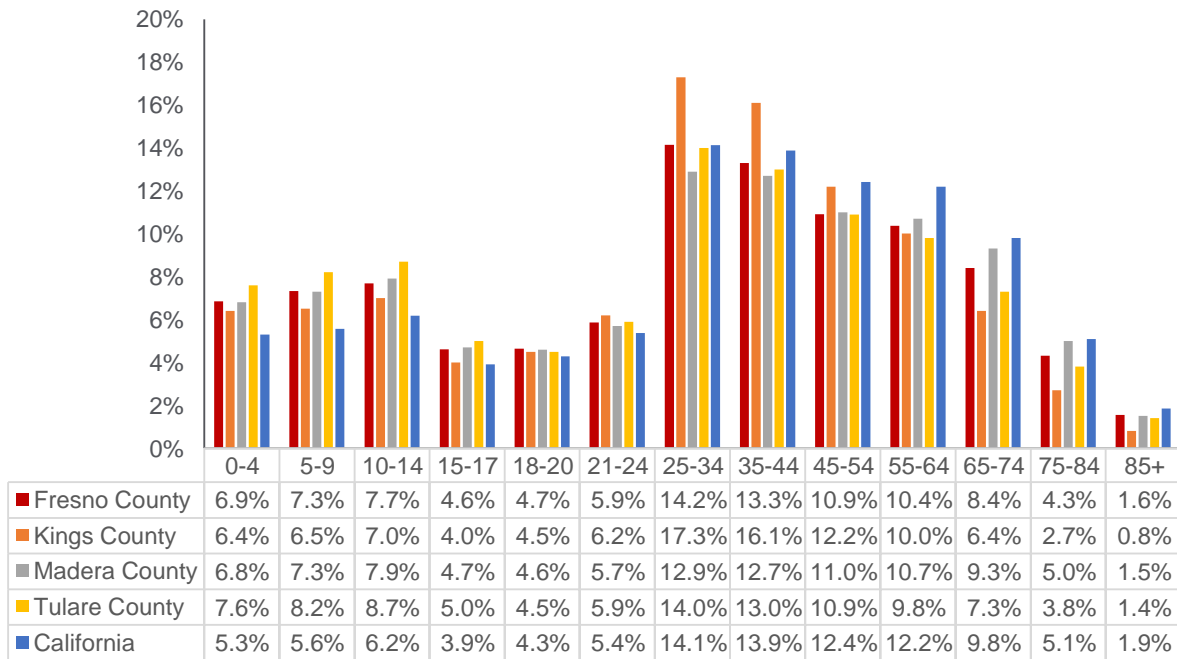
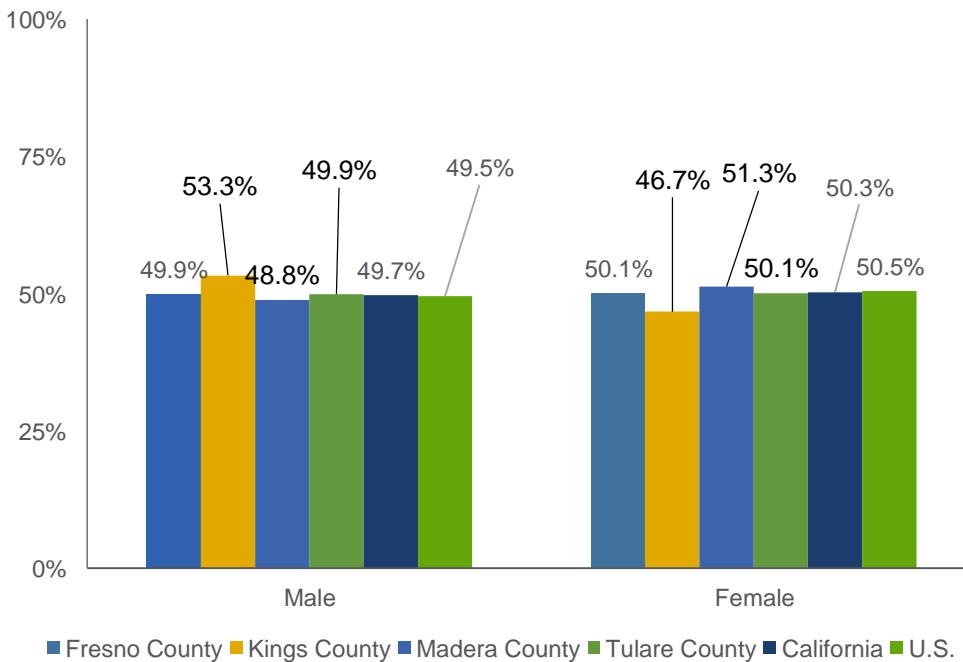
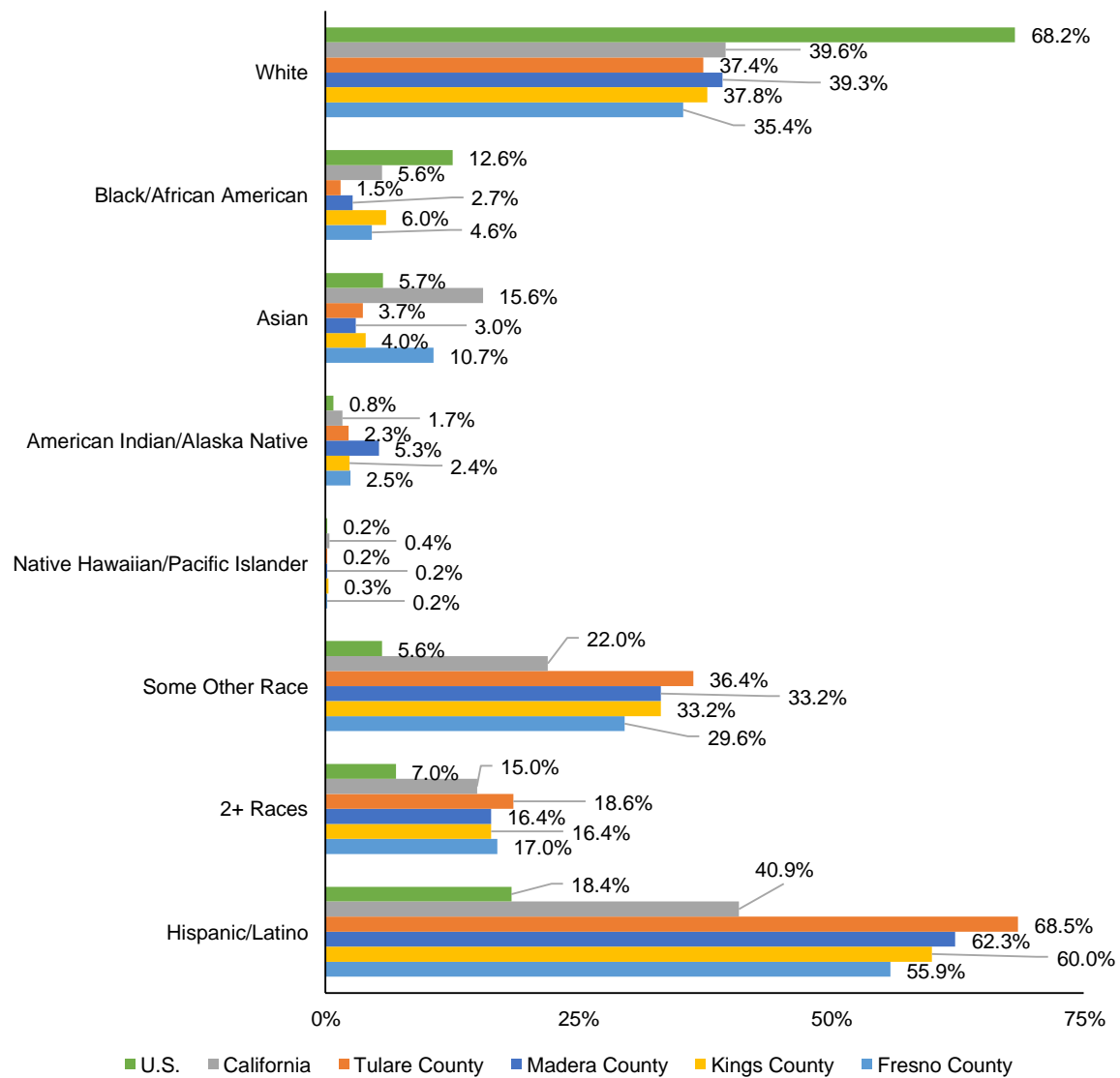


FIGURE 6. PERCENT POPULATION BY SEX: COUNTY, STATE AND NATION



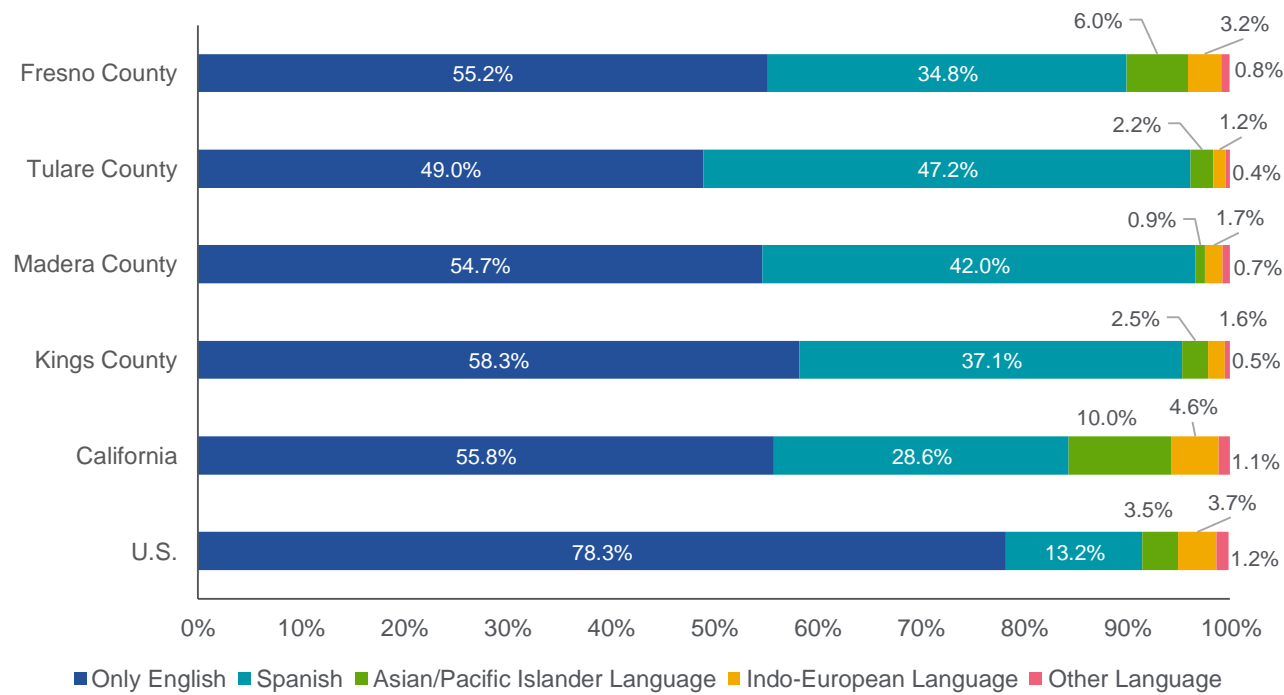

FIGURE 7. POPULATION BY RACE AND ETHNICITY



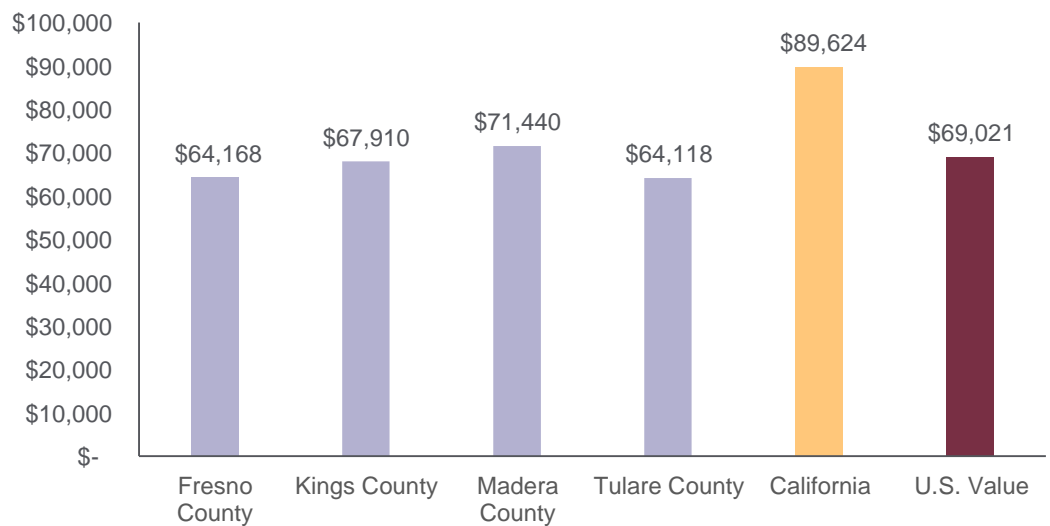

FIGURE 8. POPULATION AGE 5+ BY LANGUAGE SPOKEN AT HOME



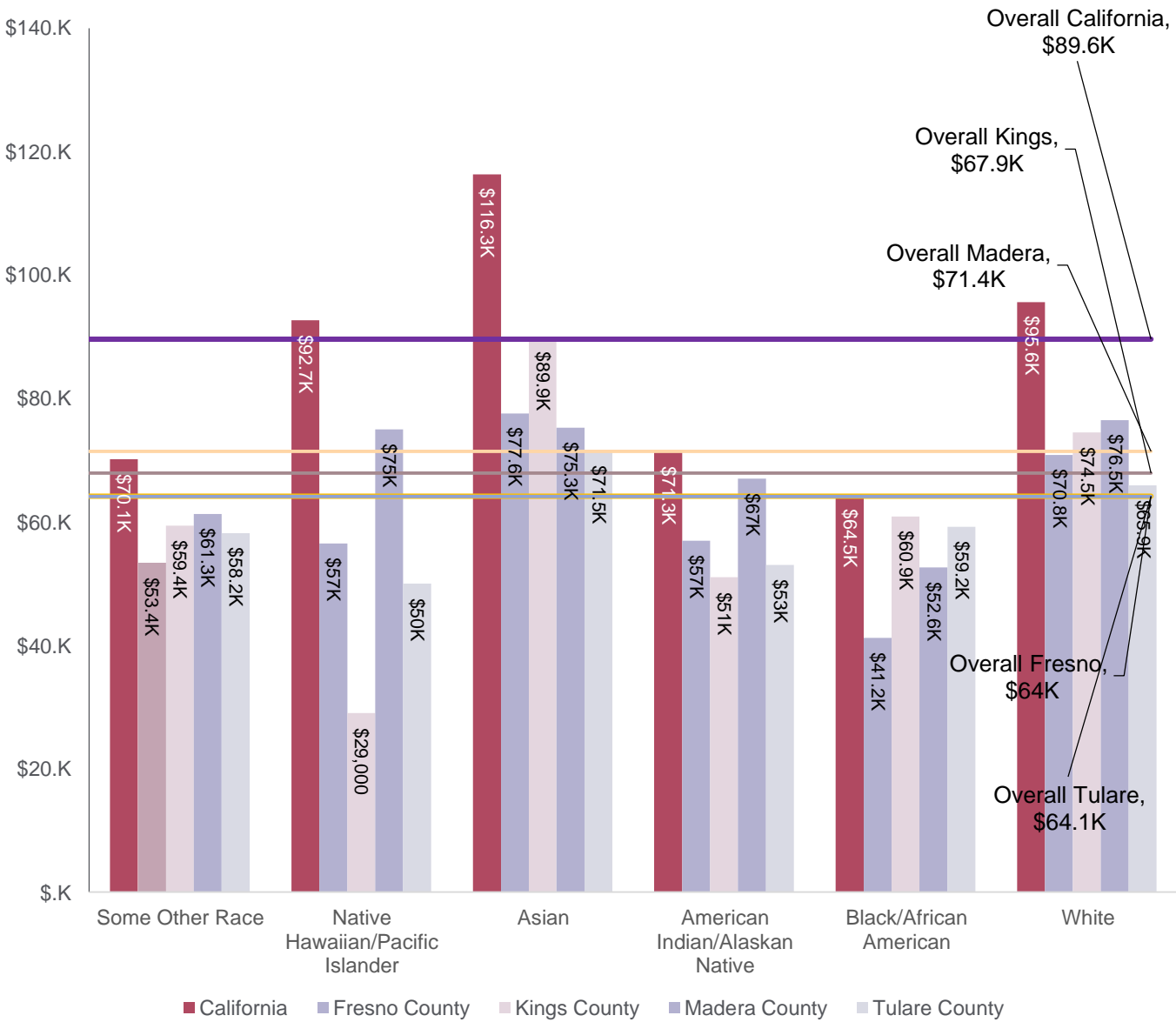

FIGURE 11. PERCENT OF FAMILIES LIVING BELOW POVERTY LEVEL BY ZIP CODE FRESNO COUNTY

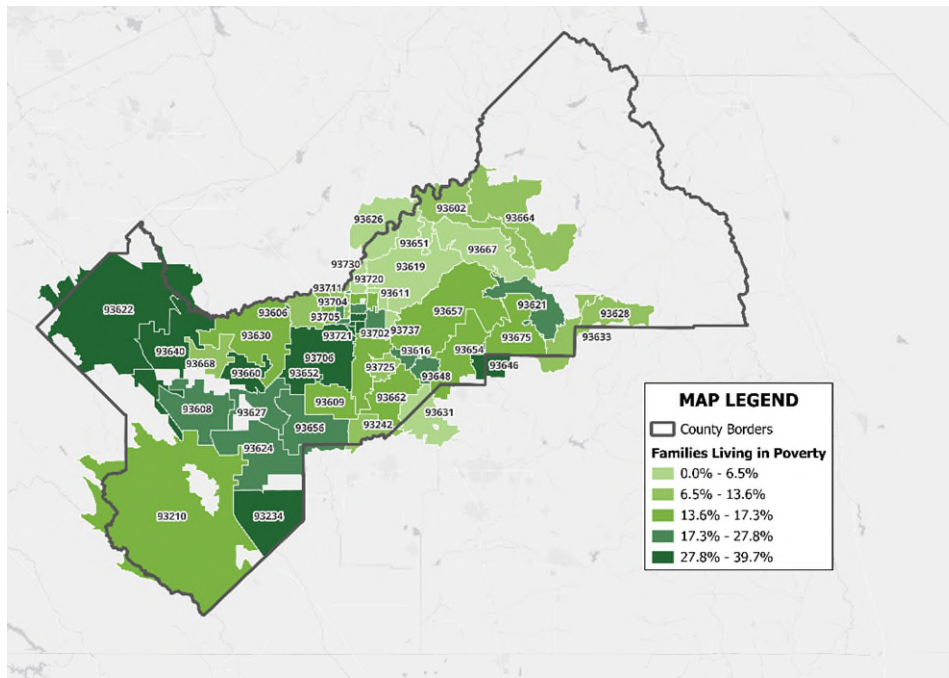
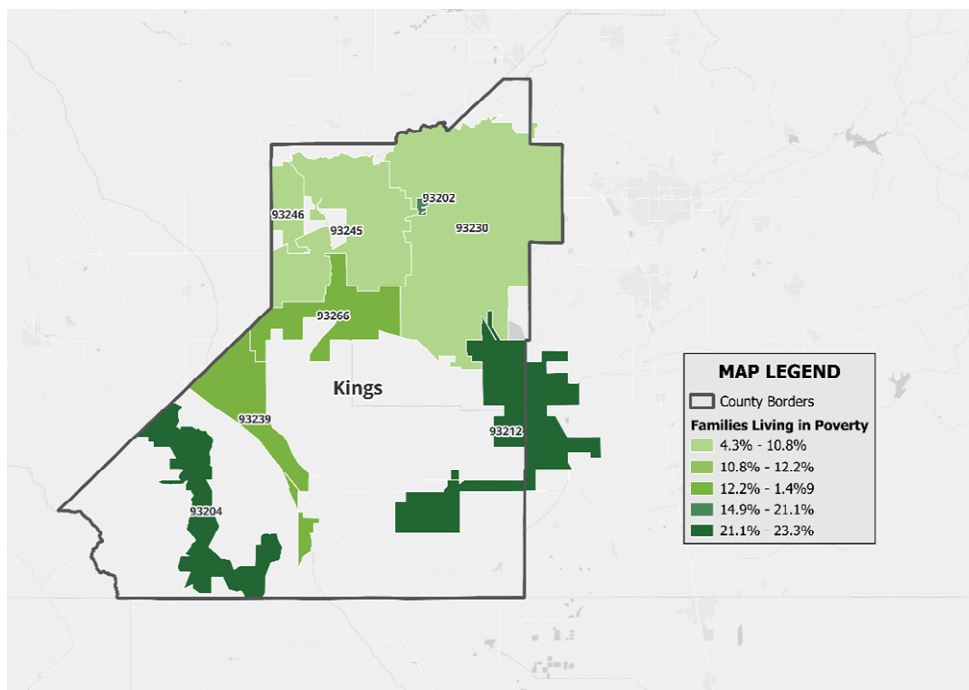


FIGURE 12. PERCENT OF FAMILIES LIVING BELOW POVERTY LEVEL BY ZIP CODE KINGS COUNTY

FIGURE 13. PERCENT OF FAMILIES LIVING BELOW POVERTY LEVEL BY ZIP CODE MADERA COUNTY

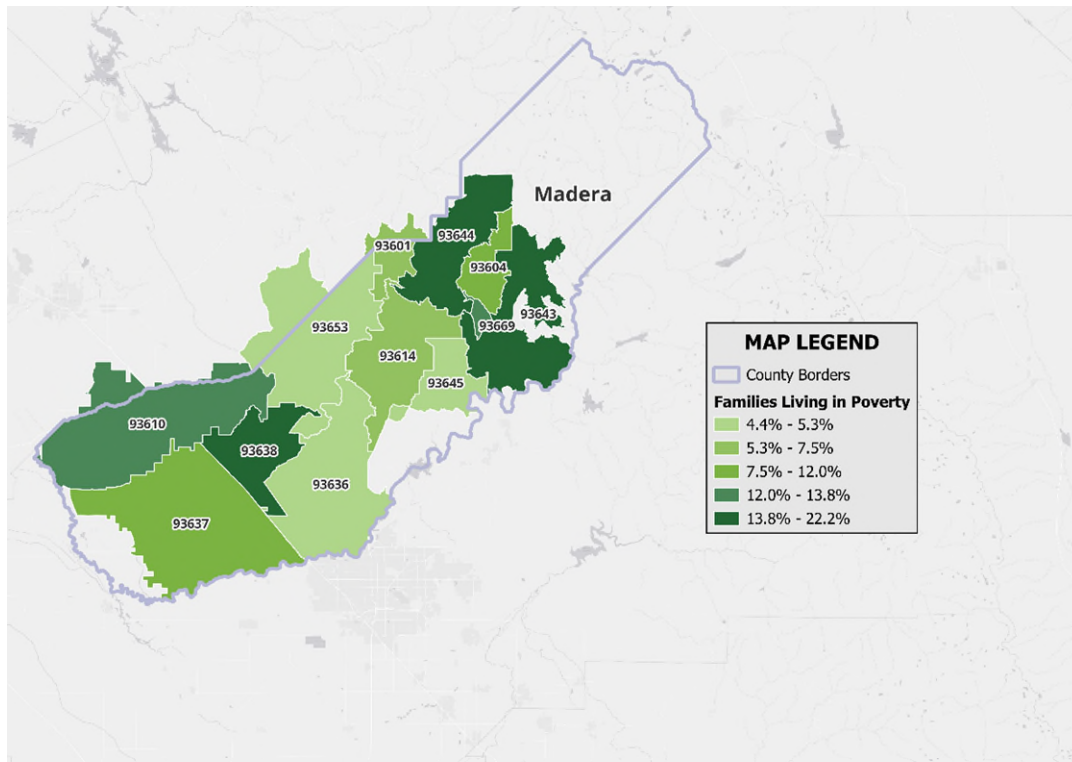
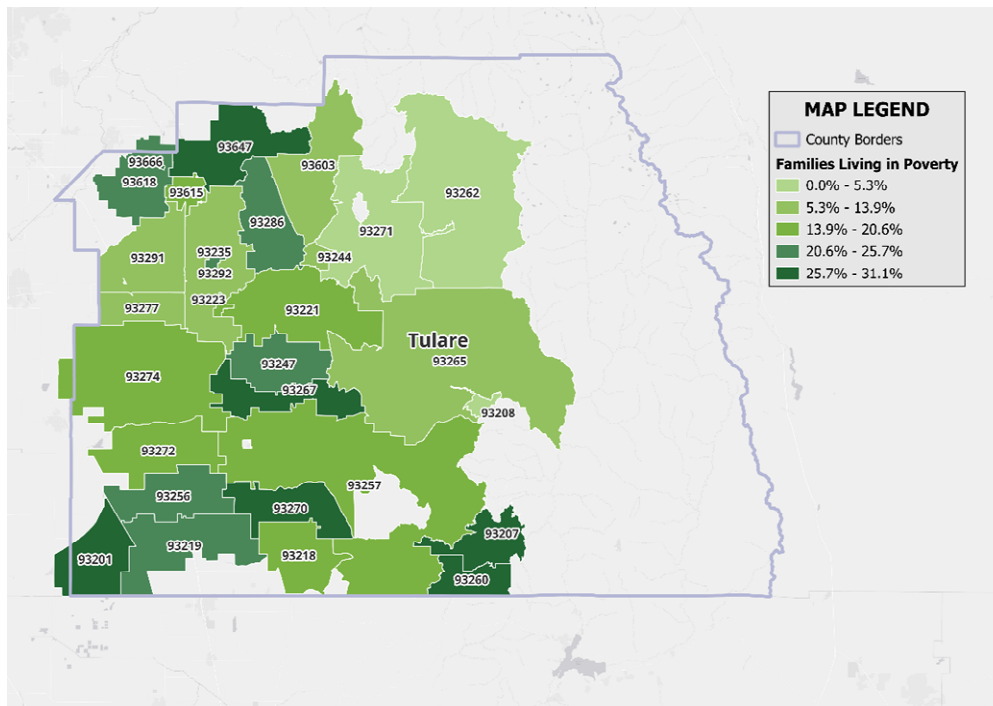


FIGURE 14. PERCENT OF FAMILIES LIVING BELOW POVERTY LEVEL BY ZIP CODE TULARE COUNTY

FIGURE 15. POPULATION 16+ UNEMPLOYED: COUNTIES, STATE, AND U.S.

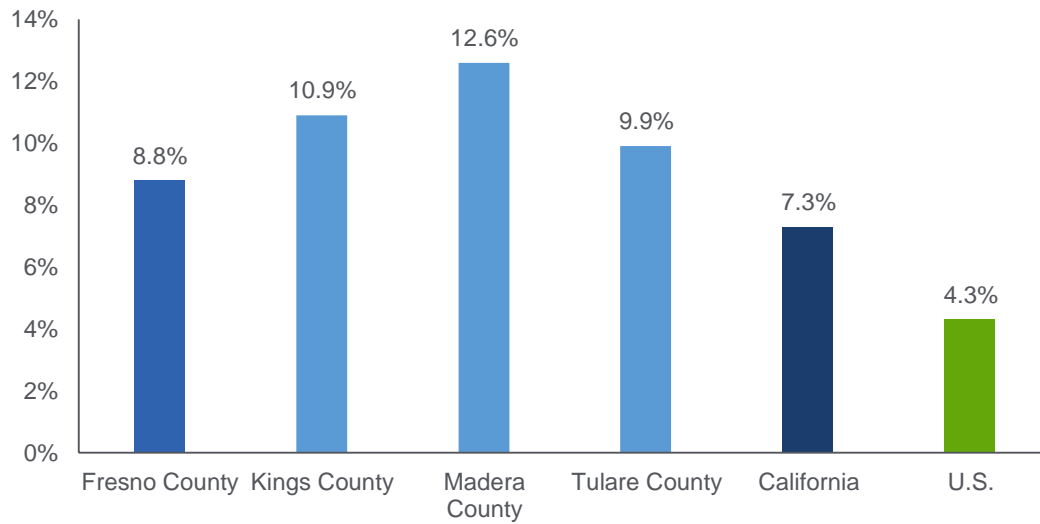
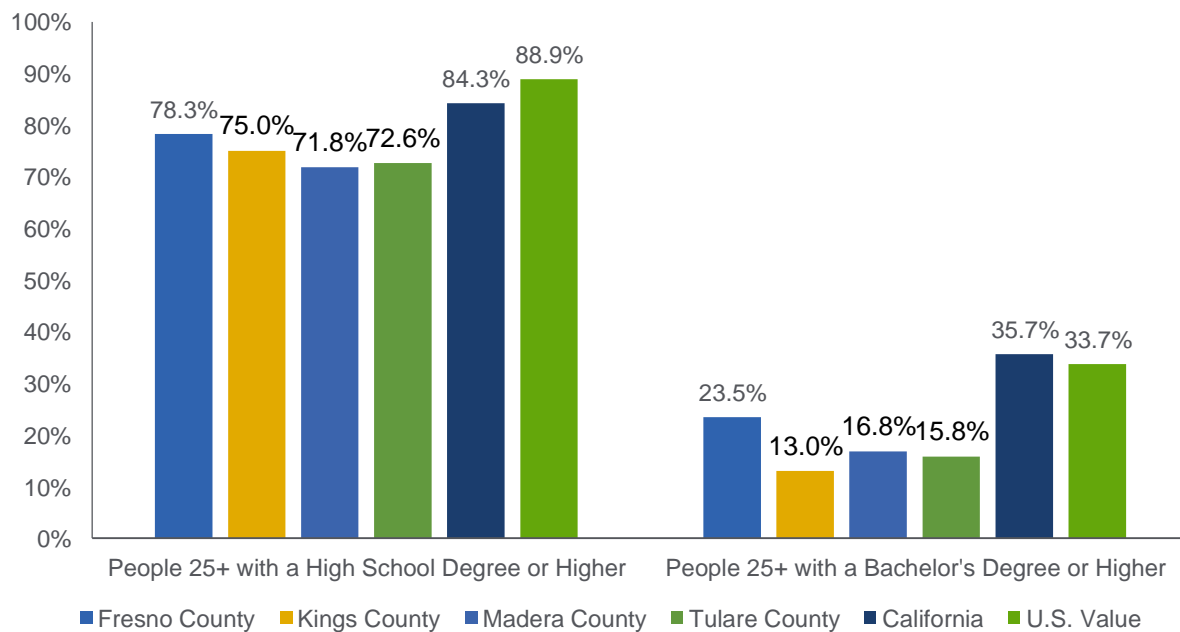
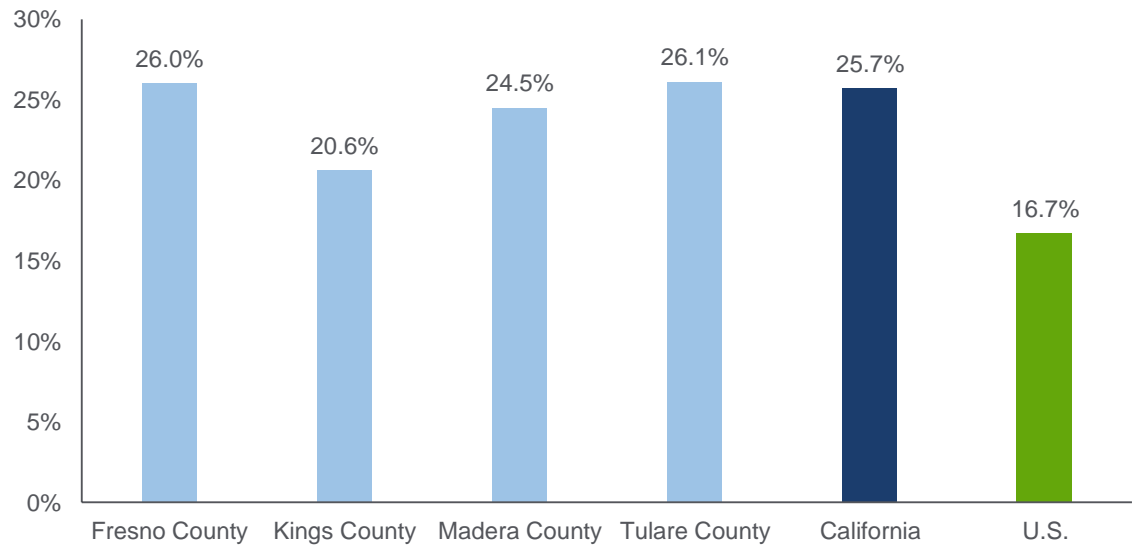


FIGURE 16. POPULATION BY EDUCATIONAL ATTAINMENT, AGE 25+



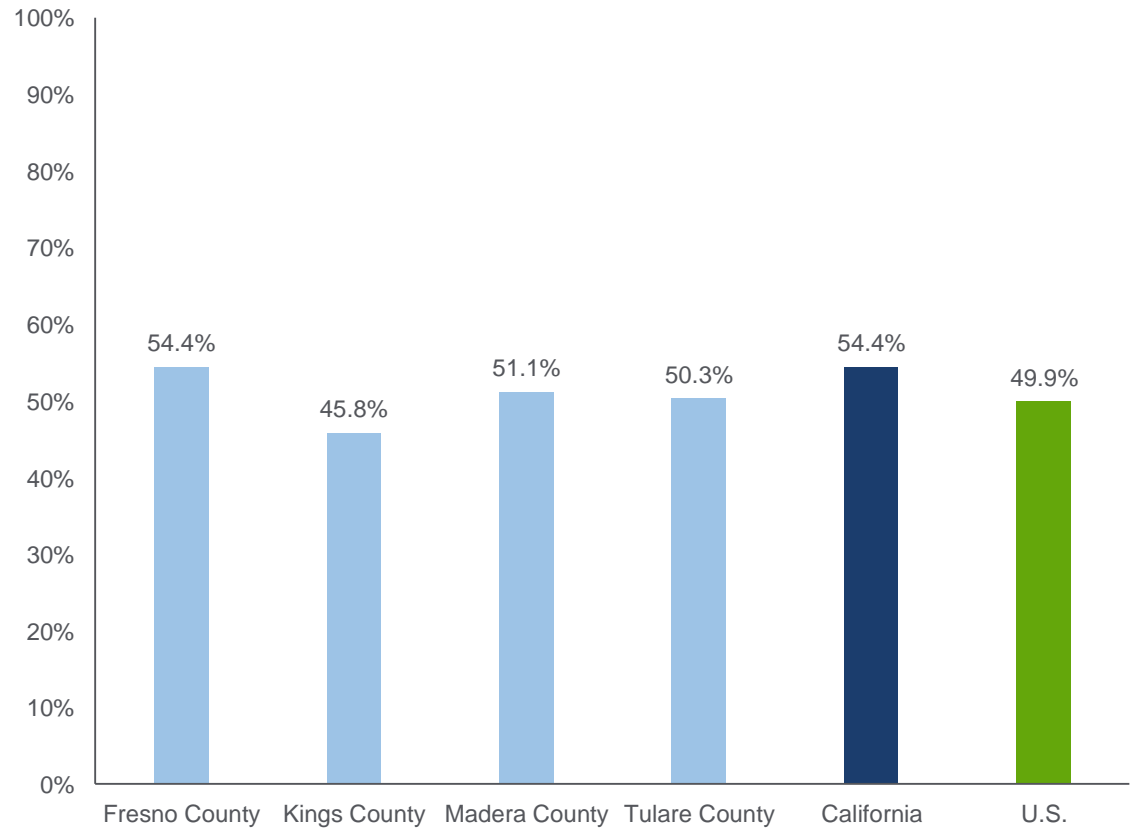

FIGURE 17. HOUSEHOLDS WITH SEVERE HOUSING PROBLEMS



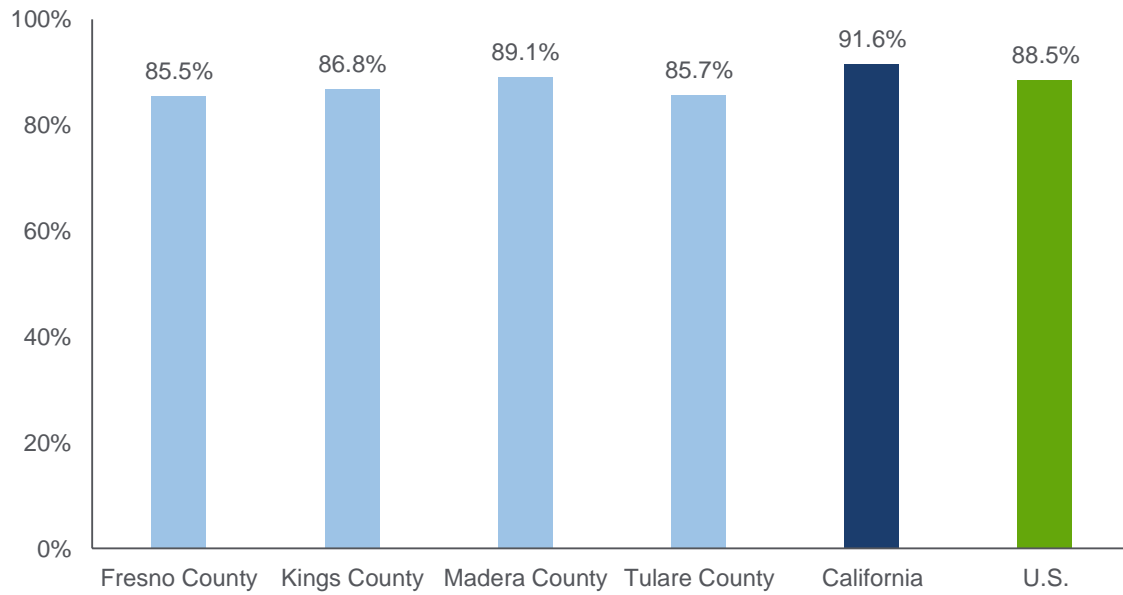

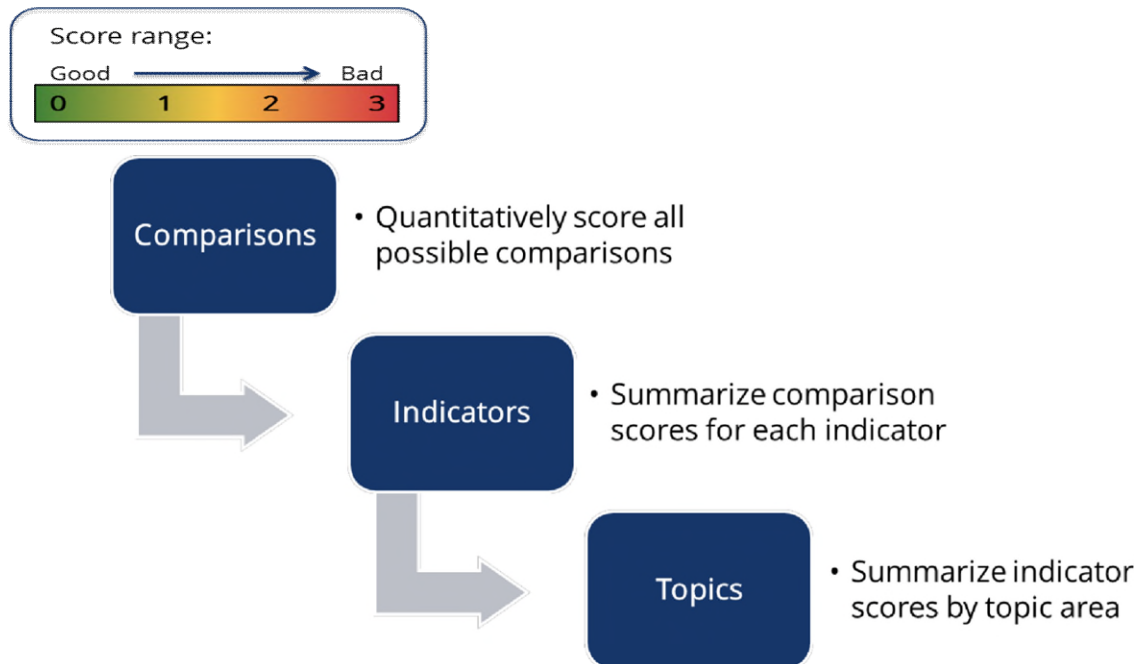
FIGURE 19. HOUSEHOLDS WITH AN INTERNET SUBSCRIPTION

Secondary Data Scoring

Data Scoring is done in three stages:



For every indicator available, each county in CHS' service area is assigned a score based on its comparison to other communities, whether health targets have been met and the trend of the indicator value over time. These comparison scores range from 0-3, where 0 indicates the best outcome and 3 the worst. The availability of each type of comparison varies by indicator and depends upon the data source, comparability with data collected for other communities and changes in methodology over time. Indicators are categorized into topics and each topic receives a score. Indicators may be categorized in more than one topic. Topic scores are determined by the comparisons of all indicators within the topic. Secondary data for this report are up to date as of October 7, 2024.

Comparison of Values: County

For ease of interpretation and analysis, indicator data on the Community Dashboard is visually represented as a green-yellow-red gauge showing how the community is faring against a distribution of counties in the state or the United States. A distribution is created by taking all county values within the state or nation, ordering them from low to high and dividing them into three groups (green, yellow, red) based on their order. Indicators with the poorest comparisons ("in the red") scored high, whereas indicators with good comparisons ("in the green") scored low.

Comparison of Values: State, National and Targets

The county is compared to the state, national and target values. Target values include the nationwide Healthy People 2030 (HP2030) goals. Healthy People 2030 goals are national objectives for improving the health of the nation and are set by the Department of Health and Human Services' (DHHS) Healthy People Initiative. For all value comparisons, the scoring depends on whether the county value is better or worse than the comparison value, as well as how close the county value is to the target value.

Trend Over Time

The Mann-Kendall statistical test for trend was used to assess whether the county value is increasing or decreasing over time and whether the trend is statistically significant. The comparison uses the four most recent comparable values for the county and statistical significance is determined at the 90% confidence level. For each indicator with values available for four time periods, scoring was determined by direction of the trend and statistical significance.

Indicator Scoring

Indicator scores are calculated as a weighted average of all included comparison scores. If none of the included comparison types are possible for an indicator, no score is calculated and the indicator is excluded from the data scoring results.

Topic Scoring

Each topic's score is calculated by averaging the corresponding indicator scores. Each indicator may be included in up to three topic areas. Resulting scores range from 0-3, where a higher score indicates a greater level of need as evidenced by the data. A topic's score is only calculated if it includes at least three indicators.

Secondary Data Source Keys

Appendix B: Community Survey Results

Surveys were offered and completed in English, Spanish, Hmong and Punjabi. When participants were asked race and/or their ethnicity, approximately 56% described themselves as Hispanic or Latino and 35.64% as White (Figure 20). The largest age group ranged from 25-34, followed by 35-44 (Figure 21). Most respondents identified as woman (77.82%) (Figure 22) and 28.46% had a bachelor's degree, followed by 24.95% high school graduate, diploma or equivalent to a GED (Figure 23).

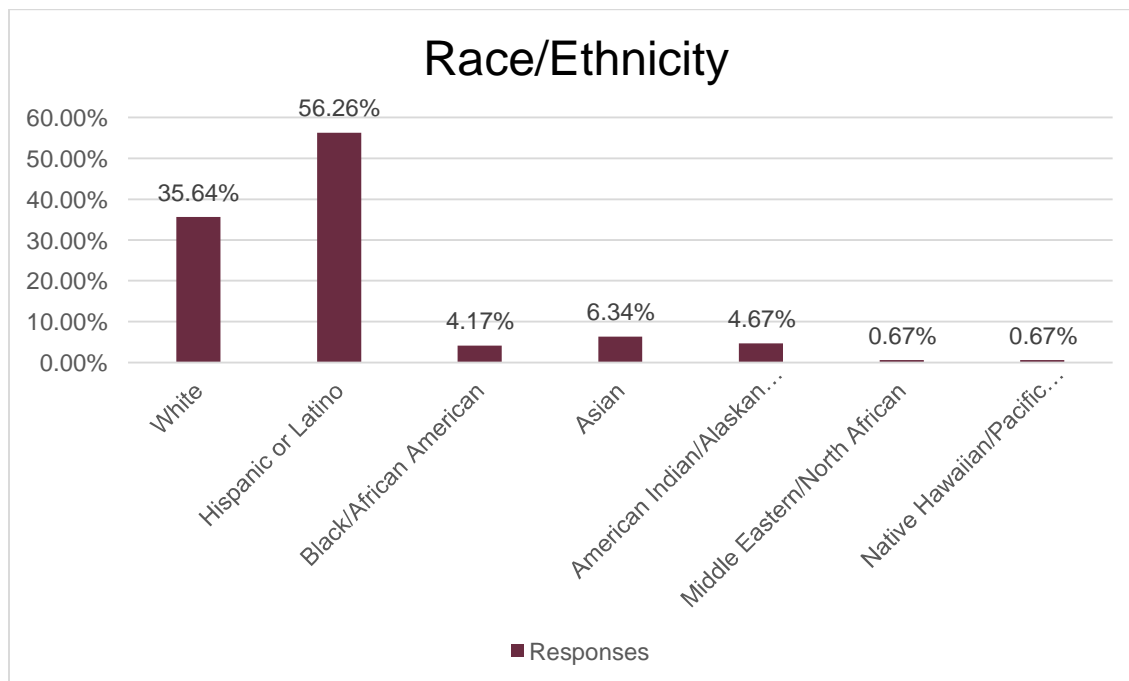

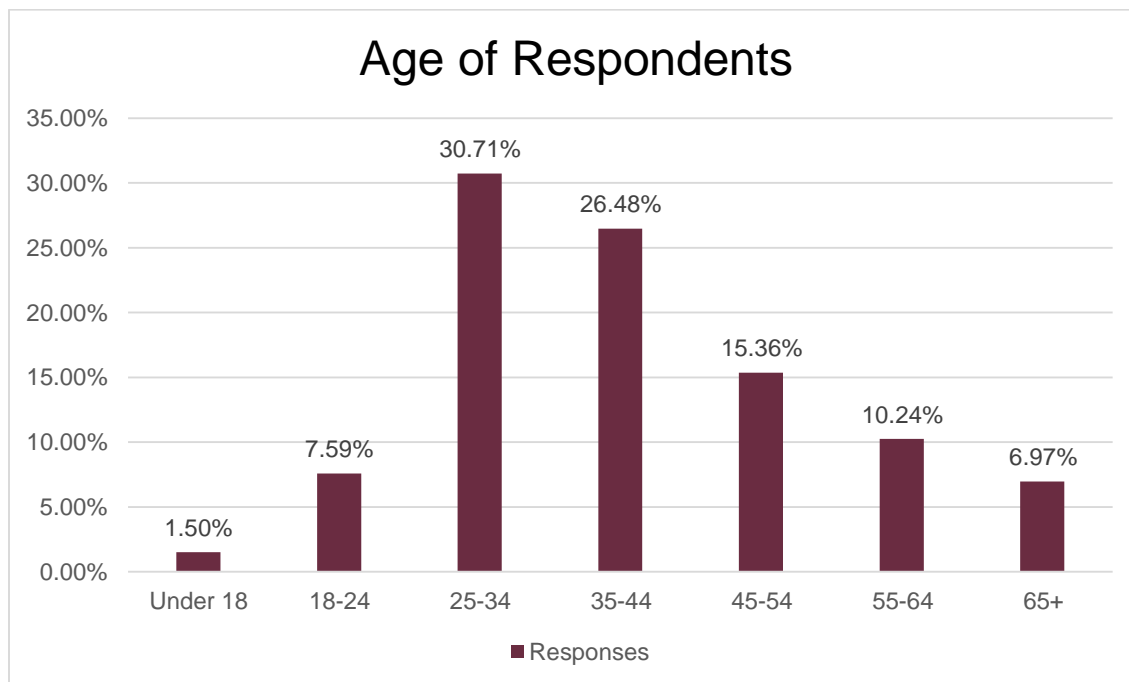

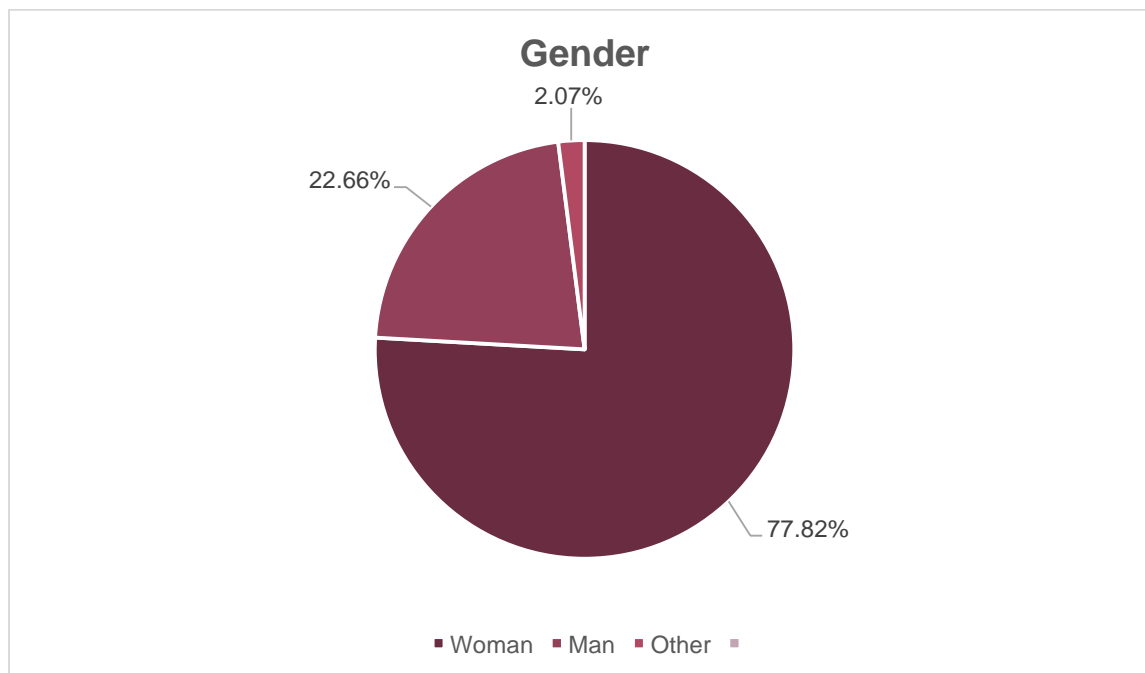
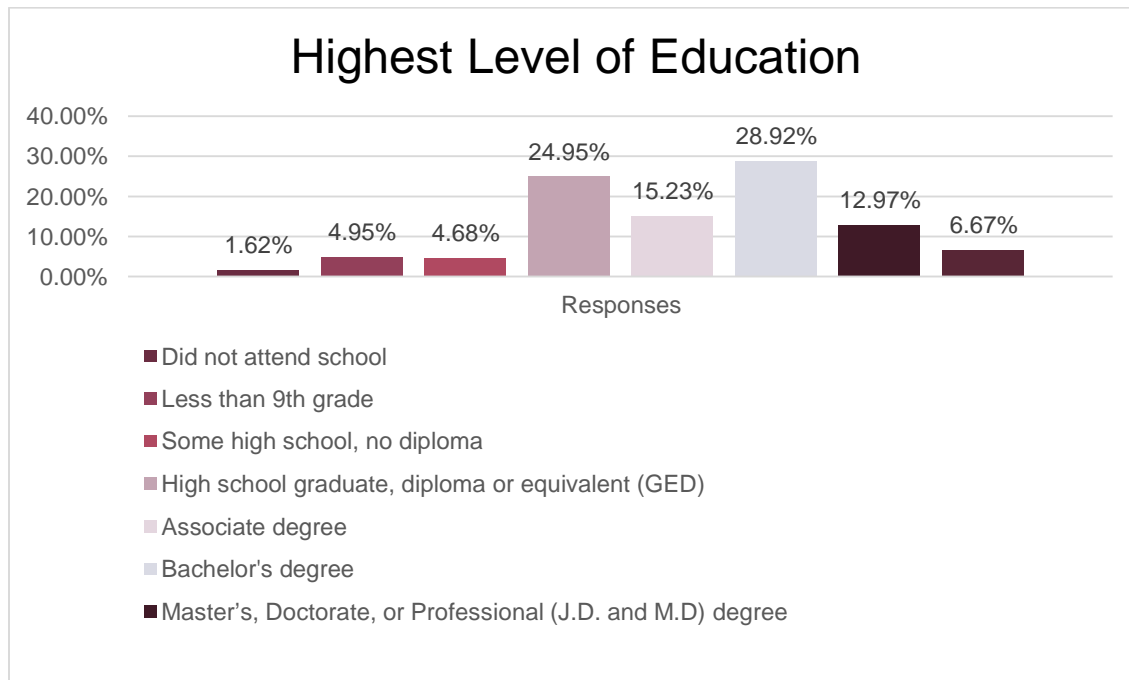

The survey asked participants about important health and quality of life challenges in their communities. 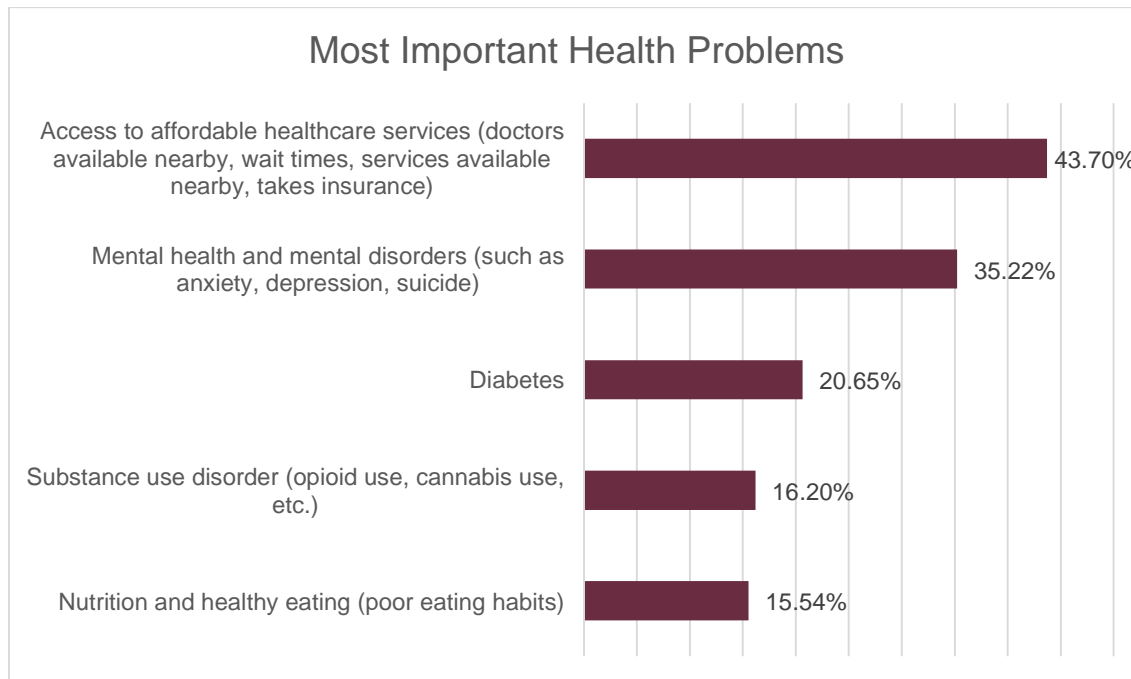
